In consideration of being permitted to utilize the facilities of Paintball Addicts LLC, I hereby agree as follows:

1. I release and discharge the owners of the property and/or PAINTBALL ADDICTS LLC and any of its agents and/or representatives from ANY and ALL LIABILITY, claims, demands or causes of actions that I may hereafter have for injuries and other damages or losses arising out of my participation in and/or observation of paintball.
2. I understand that I may be injured or die while playing and/or observing paintball.
3. I understand that even if all the safety rules are followed, that paintball is an inherently dangerous sport. I freely and voluntarily accept the risk of injury or death from participation in and/or observation of paintball.
4. I understand that serious and permanent eye injury, including loss of eyesight, can occur if I do not wear approved paintball safety goggles and mask while in any area where paintball guns may be intentionally or accidentally discharged. I agree to never remove my goggles under any circumstances while I am in designated areas.
5. I understand that although the field operator and the staff will attempt to enforce safety and playing rules, I may be injured or die because of other persons not following the rules.
6. I understand that I will be exposed to risks and hazards while on these premises. I freely and voluntarily acknowledge these risks and hazards and nonetheless wish to play and/or observe paintball.
7. I understand that playing paintball involves risks which include, but are not limited to, the risk of injury from being hit by a paintball, injuries from possible malfunction of equipment, and injury from falling over natural or manmade obstacles on the game fields.
8. I hereby certify that I do not suffer from any physical infirmities, chronic illnesses or physical disabilities which are affected by or prohibit me from engaging and participating in the sport of paintball. I understand that I am responsible for consulting a physician before I play and/or observe paintball.
9. As a condition of playing paintball on these premises and/or to be allowed on these premises, I knowingly and voluntarily waive my legal rights that I may have against the field operator, landowner, equipment manufacturers and distributors, and Paintball Addicts LLC, its owners, employees, directors, officers, representatives, and assigns.
10. I agree to hold harmless each and all of the above parties and to indemnify each and all of the above named parties against any and all claims, actions, suits, costs, expenses (including attorney's fees), damages, and liabilities arising out of, connected with, or resulting from my playing and/or observing paintball.
11. I assume full responsibility for usage and return of any and all safety and rental equipment issued to me by PAINTBALL ADDICTS LLC. I agree to reimburse PAINTBALL ADDICTS LLC at retail value for any lost or damaged equipment, including, but not limited to, paintball guns, air tanks, masks, barrel plugs or any other equipment provided by PAINTBALL ADDICTS LLC.
12. I understand only approved paintballs purchased at Paintball Addicts may be used within Paintball Addicts.
13. I agree to abide by all safety and game rules of Paintball Addicts.
